## **Membership Terms & Conditions**

- 1. Membership: Members are required to download the Wexford Club application. On the application you will generate a QR Code which you will use to sign in to the club on the scanner at reception. You will be able to manage all your memberships requirement through the app including booking of classes.
- 2. Rules & Regulations: The Wexford Club is a private members club. We reserve the right to withhold membership as management sees fit, particularly in relation to membership numbers and safety reasons. The member acknowledges to have carefully read the rules & regulations of the club and fully understands these terms and conditions. These must be observed at all times:
  - > Sport outfit and sport shoes are required in the gym. Flip flops, swimming hats and appropriate swimwear are compulsory in the pool area. Jewelry is not permitted in the pool area.
  - Gym access is for over 16 years old only.
  - ➤ Children under the age of 15 must be supervised by an adult while in the pool.
  - Children under 16 years old are not permitted to use sauna, steam room or jacuzzi.
  - Spectators must wear blue shoe covers when entering the pool area and changing rooms
  - No throwing, jumping or diving in the pool
  - Please do not pull on the Lane ropes
  - Family Swim Times: Children swim times are from 9am to 7pm daily.
  - No phones are allowed on the pool deck.
  - ➤ All classes must be pre-booked.
  - We are not liable for members' personal belongings.
  - Members are responsible for maintaining a clean and respectful environment within the health club.
- **3. Usage Policy:** Only person(s) stated on the membership form may avail of the facilities. Membership is not transferable. Membership of The Wexford Club will entitle the members to use the facilities at the times designated for their membership type. Use of the Facilities of The Wexford Club and use of the club premises are strictly subject to the Rules & Regulations of the club in effect at any time.
- **4. Classes:** A minimum of 2 persons is required for all fitness classes to go ahead on a daily basis Club Management reserves the right to change class timetable or cancel the class with or without prior notice.
- 5. Management: Membership may be terminated by the management for violation of any rules or regulations of the club or for conduct deemed by the management to be detrimental to the welfare, safety or character of the club or its members. Management reserves the right to utilize The Wexford Club facilities for special events. The management of the club reserves the right to amend the terms and conditions of membership and rules as it sees fit the member shall observe any amended or additional conditions or rules so made. In the event of a dispute arising between a member and management of the club, the decision of the management is final.
- 6. Data: All member's personal data will be kept on file for 12 months after membership has expired.

- 7. Freeze Policy You may freeze your account for a minimum of 1 month, up to a maximum of three months per annum. Holiday Suspensions incur a €10. Fee. Terms and conditions apply. Written notification must be given to the club manager.
- **8. Health:** The member must acknowledge any illnesses or diseases. The member acknowledges that the club accepts no liability whatsoever for any personal injury or damage, loss to personal property sustained by the member while he/she is using the Club premises, facilities, or parking areas.
- 9. Membership Charges: We have a choice of memberships at the Wexford Club to suit you each individual. One of which is the recurring payment option, if this does not suit your needs please contact the team and we can change this for you. This is based on a recurring payment basis and carries over every month on the 1<sup>st</sup> day of unless cancelled. If you wish to cancel your memebrship 30 days notice must be given in writing to the Wexford Club manager only.
- **10.** Cancellation Policy: Cancellation of membership will be considered by circumstance. Relevant documentation must be provided by the member 1 month in advance of the cancellation date by email to the club manager. All cancellations are subject to management's discretion.
